**Sub: Grant of extended free days for levy of demurrage on Import Cargo and Licence (Storage) fees on containers.**

Ref : This office Circular No. TM/M/13-5/Circular/23 of 95-96 dated 16.11.2019.

-----  
By circular dated 16.11.2019 referred to above, the facility of extended free days for cargo/containers till 19.11.2020 was conveyed.

2. The sanction has been obtained to continue the said scheme of extended free days for cargoes and containers for one year from 20.11.2020 to 19.11.2021 as under :

I. Import cargoes - Break Bulk and Containerised :

Sr. No.	CATEGORY	FREE DAYS
(i)	Containerised cargo	7 calendar free days following the date of vessel completing discharging operations.
(ii)	Other import cargo	6 calendar free days following the date of vessel completing discharging operations.
(iii)	Non-Containerised transshipment cargo	10 calendar free days following the date of vessel completing discharging operations

II. Containers – (Import & Export):

Sr. No.	CATEGORY	FREE DAYS
(i)	Loaded Import Containers	5 days from the date of completion of vessel's import operations.
(ii)	Loaded Export Containers	15 days from the date of stuffing of containers at Port's CFSs or from the date of bringing in of fully loaded containers in Port premises.
(iii)	Empty Containers	7 days from the date of completion of vessel's import operations or from the date of receipt of export containers.
(iv)	ICD Containers	15 days from the date of completion of vessel's import operation or from the date of receipt of export containers.
(v)	Transshipment-loaded/ Empty Containers & Export Containers brought under Shipping Bills by sea from other ports for shipment.	15 days from the date of completion of vessel's import operations.

Note : The free days are calendar days and in computing number of free days, Dock holidays, Sundays, Custom holidays shall be included.

3. The trade may please note that the delivery of the import cargo should be taken expeditiously and if the delivery is slowed down / stopped for any purpose, which results in hindrance of vessel's discharge/loading operations at the berth, the importers/agents of the vessel/exporters shall arrange to shift the cargoes/containers to the place indicated/nominated by the Port, failing which the Port will arrange to shift the same at the cost of the importer/exporter.
4. The Port users are requested to take note of the above.
